East Knoyle Workhouse

Built in 1811 and closed 1836-1837, East Knoyle workhouse stood on the road leading from the village to Hindon and came under the wing of the Mere Union. Each Union had a Board of Guardians, Medical Officer, and Registrars responsible for births, marriages and deaths. When the East Knoyle workhouse closed, paupers from East Knoyle went to the Mere Union about 5 miles away. Advertisements for contracts and tenders to supply the Union appeared in the local newspapers:

District No 2 - Zeals, Silton, Bourton, Stourton with Gasper, Kilmington, and Maiden Bradley, with Yarnfield

The Board of Guardians of this Union are ready to receive proposals from MEDICAL GENTLEMEN willing to contract for attendance, supply of medicine, &c. as under-mentioned, to the paupers of either of the above districts, for one year, from the 25th day of March next

The Contract to include supply of the best Medicine, Epidemics, Accidents, parochial cases of all descriptions, Medical and Surgical, with regular attendance, and to attend inquests if required by the Coroner

All Tenders to be sent sealed, indorsed, "Medical Tender", directed to the Chairman of the Board of Guardians, and to be delivered at the Vestry Room, in Mere, on or before Monday, the 29th day of February inst., on which day, at half past ten o'clock in the forenoon, the Guardians will meet and open the tenders

Men, Women's and Children's Stockings, stout worsted, at per pair; stout Calico at per yard; Flannel at per yard; Blankets (stating size) at per pair; Sheets, stout brown cotton, ditto; Counterpanes, stout cotton, ditto and Coverlids; Blue Cotton for gowns at per yard; and general clothing for Paupers, with the price and quality of each article

Samples to be produced and the articles to be delivered at the Workhouses at such time and in such quantities as the Guardians shall direct

And persons willing to supply the said Guardians with Bread 4bls 4oz and 2lbs 2oz per loaf, best seconds, for the under-mentioned Parishes, from the said 25th instant until the said 24th day of June, are requested to deliver or send Tenders, as above, on or before the 19th instant

Bread to be delivered in the parishes of District No 1, being Sedgehill, East Knoyle, West Knoyle, Kingston and Monckton Deverill, Pertwood and Mere (Zeals excepted); and in the parishes of District No 2, being Zeals, Silton, Bourton, Stourton with Gaspar, Kilmington and Maiden Bradley, with Yarnfield And to be delivered in the parishes in such quantities and at such times and places as the Relieving Officers shall direct Security to be given (if required) for the performance of the contract
